The information we collect and why

We collect information from you and your computer when you visit our Website. We collect both personally identifiable and non-personally identifiable information. We also collect information from you when you request support or make enquiries about our products or services. Jetstack Ltd owns all information we collect from our users.

We may ask you to provide us with personally identifiable information at various points while you use our Website, such as when you enquire about products or services from us. Examples of the types of information we may collect include: your full name, job title, company name and address, phone or fax number, e-mail address, and interest areas and preferences. Jetstack owns all information we collect on this Website.

We may use the personally identifiable information you provide about yourself to fulfil your requests for products and services, to contact you about your account, to complete and support your activities, to respond to your enquiries about our offerings, and to customize the content of our Website. We may use your e-mail address and other personally identifiable information to send you service notifications about your account, about the services you currently use, if any, and concerning changes to our Privacy Policy or other legal or policy matters. If you have given us permission, we may use your e-mail address and other personally identifiable information to provide you with information about products and services we believe may be of interest to you.

We also collect non-personally identifiable information, including information about the way in which our Website is used. This non-personally identifiable information includes information stored in the log files for our Web site or any analytics services we might use. We may use this information to improve and tailor the content of our Website.

What data is/can be shared with third-parties and why?

When you visit our Website, we may share anonymous, statistical information about you with third parties, including our vendors, customers, potential customers, and corporate partners. We do not link this statistical information to your personally identifiable information, or to any identifiable individual.

We may contract with other companies in order to provide some of the services we offer to visitors to our Website. If we do so, we will share your name and personally identifiable information with these companies to the extent necessary to provide you with the service you have requested, and we require that other companies treat your information in a manner consistent with this Privacy Policy.

In addition, we may partner with other companies to provide you with third party products and services. When you sign up for these services, we will share your name and any other personally identifiable information you expressly provide to such third parties in order to provide their products or services to you.

Please note that this Privacy Policy does not cover our partners' use of your information, so we encourage you to read a partner's privacy policy before signing up for any of its products or services.

Sharing data outside the EEA

The internet is a global environment. The data that we collect from you may be transferred to, and stored at, international destinations, including destinations outside the European Economic Area ("EEA"). It may also be processed by international staff or data processors outside this area, who may be engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services. Jetstack will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.

How do we keep your data safe?

We take measures to protect the security of all personally identifiable information we possess and collect. These measures include:

- Encrypting sensitive information during transmission,
- Limiting the number of our employees who have access to personally identifiable information,
- Requiring employees with access to personally identifiable information to take appropriate measure to safeguard it
- Storing your information in secure places that are protected using standard security technologies

Schrems II

The Schrems II ruling states that Jetstack as 'data controllers' need to assess if any third-party company has adequate protection processes in place to align with GDPR requirements specifically with regards to transferring data outside the EEA. If the third-party company in question does not have adequate processes then Jetstack has a duty of care to identify and adopt supplementary measures to ensure adequate protection/processing.

As Jetstack is owned by Venafi Inc. ("Venafi") the Schrems II ruling is relevant to the way Jetstack processes personal data. Jetstack rarely shares an individual's personal data with



Venafi. However, there are some occasions where your data might be accessible to Venafi. As a result, we have assessed Venafi's alignment to GDPR practices and can report that Venafi does follow GDPR processes and complies with GDPR requirements. Cookies

A cookie is a small text file stored on a computer that contains information associated with that computer.
